




### **FOUNDATION BUDGET**

### EITC

PVSD Foundation has been approved by the PA Department of Community and Economic Development (DCED) as an educational improvement organization for the 22-23 school year.

Through EITC, a state program that provides companies with tax credits for donations to a non-profit educational improvement organizations, a business can receive a tax credit equal to 75% of a contribution (up to \$750,000). Credits can be increased to 90% of the contribution if a business agrees to provide the same amount for two consecutive years. By donating to the Foundation through EITC, you are supporting public education and keeping state tax dollars in the local community.

Types of businesses that are eligible: C-Corporations, S-Corporations, Partnerships, Sole Proprietors, Limited Liability Companies (LLCs), Subchapter S-Corporations and other businesses that pay their state business taxes under the personal income tax on PA business income.

# GRANT SPOTLIGHT: TROUT IN THE CLASSROOM

Perkiomen Valley School District Foundation awarded Mr. Kevin Tomlinson and Ms. Kelly Voicheck a grant to start Trout in the Classroom at Evergreen Elementary School in the 2022-2023 school year.

The overall purpose of the project is to provide fourth grade students with an exciting hands-on experience to foster awareness of cold-water conservation and to encourage participation in cold water resource projects and recreation programs.

Fourth grade students had a blast learning about the development of trout from eggs to fingerlings. Students spent the first half of the year learning about trout and their environment and the second half of the year raising the trout.

After the trout eggs hatched in late January, Mr. Tomlinson and Ms. Voicheck's classroom became the talk of the school and students and teachers alike were curious to see how their new fishy friends were doing. Students acted as tour guides, explaining all that they have learned! Mr. Tomlinson reported, "It has been a neat experience to see them take on the leadership role in expanding the knowledge of the program across the building."

At the end of the year, they had a culminating event with representatives from Perkiomen Chapter of Trout Unlimited, Green Lane Park, Montgomery County Conservation at Lenape Park to release their fingerlings into the Perkiomen Creek.
